Personal accidents of pupils in "non-technical" education

- Death:	20.000 EUR
- Permanent disability:	100.000 EUR (depending on the degree of invalidity after consolidation).
- Temporary incapacity:	not covered
- Medical costs:	200% of the medical costs included in the Belgian Social Security scale , after mutual insurance contribution.

Personal accidents of pupils in "technical" education

- Death, permanent and temporary incapacity: indemnities and allowances calculated by reference to the Law of 10 April 1971 on accidents at work.
- Medical costs: 200% of the medical costs included in the Belgian Social Security scale , after mutual insurance contribution.

Accidents at work involving pupils/students on placement

Cover complies with that that provided in the Royal Decree dated 13 June 2007 amending the Royal Decree dated 25 October 1971 extending the scope of application of the Law of 10 April 1971 on accidents at work.

Medical costs are taken into account up to 200% of the medical costs included in the Belgian Social Security scale.

Cases of temporary incapacity are covered by the payment of a daily indemnity set at 90% of the victim's average daily remuneration from the first day following the date of the accident, up to the amount of the effective loss of remuneration.

The present Certificate is valid from 1/09/2018 to 31/08/2019.

Protecting your personal data

Information
